Aus jedem Staate der Union besitzt sie wenigstens zwei führende Zeitungen komplett seit dem Jahre 1870. An ausländischen Zeitungen sind, von laufenden Abonnements abgesehen, u. a. vertreten die London Gazette von 1665 bis zur Gegenwart, die London Times seit 1796, London Chronicle von 1757 bis 1799 und von 1814 bis 1861, London Advertiser von 1730 bis 1795, der Moniteur universel und das Journal des Débats seit 1789, die (Augsburger, später Münchener) Allgemeine Zeitung ebenfalls seit 1789 u. s. f.
